- (ii) have not been in any virus variant area in the last 14 days, or in any high incidence area² in the last 5 days, **and**
- (iii) have been fully vaccinated against Covid-19 with a vaccine approved by the World Health Organization WHO under its licensing conditions, **or**
- (iv) have recovered from an infection with SARS-CoV-2 confirmed through PCR testing within the last 6 months (the PCR certificate must be at least 28 days old), **or**
- (v) have a current negative antigen or PCR test result. The test result may not be more than 24 hours old.

In case of doubt, we reserve the right to ask visitors to the premises to take a rapid antigen test, which will be carried out by our occupational health service or another qualified service.

If you are not able to sign this form, we must refuse you entry to our premises. Thank you for your understanding and cooperation.

2. For what purposes and on what legal basis will your personal data be processed?

Knorr-Bremse processes your personal data to minimize possible infection risks in connection with the spread of the coronavirus. The legal basis is our legitimate interest in protecting our employees and business partners pursuant to point (f) of Article 6(1) GDPR and in protection against serious health risks pursuant to point (i) of Article 9(2) GDPR in conjunction with Sec. 22 (1) (1) (c) of the German Federal Data Protection Act (BDSG).

3. Will your data be divulged to third parties or transferred to third countries?

We contract with carefully selected service providers to process data for our visitor administration activities. Your data will be processed exclusively within Germany and will not be shared with third parties.

4. When will your personal data be erased?

The self-disclosure is erased three weeks after your visit to Knorr-Bremse.

5. What are your rights with regard to the processing of your data?

Where the legal prerequisites are met, you have the following rights:

- the right of access to your personal data,
- the right to request rectification of incorrect or incomplete data,
- the right to request the erasure of your personal data,
- the right to request restriction of the processing of your personal data,
- within the scope of the statutory specifications, the right to request that your personal data be transferred, and
- the right to object to the processing of your personal data.
